## Instant Bond-ification

In these times of instant gratification, it's gratifying to know that you can instantly repair, bond, and fill your wood projects with CA (cyanoacrylic) glues.

CA glues adhere just about anything to just about anything else in a period of one to thirty seconds. The only requirement is that at least one of the two surfaces needs to be porous. You speed the cure by use of an accelerant and being mindful of temperature and moisture (more of these speeds the cure) and the viscosity of the CA is also a factor (thin, medium, thick, gel). You can select different viscosities to control flow, spread, penetration; and to deal with larger voids and gaps in the material you are working with.

I have been using and enjoying CA glue for years, but recently discovered a few things I didn't know. I feel the need to share basic best practices & a few new nuggets of information in case they are as meaningful to others – as they were to me.

- prematurely hardened product.
- carved items and disguising repairs.)
- them together.
- bark color, or for contrast.
- 6. Always clean your applicator tips in acetone after each use.

One last point which can be important if you are a CA newbie; Don't be so focused on speed that you instantly glue yourself to your work. Just in case, it's good to have nail polish remover or de-bonder on hand 😳

1. Not all CA glues are created equal. Cheaper, less pure CAs have a shorter shelf-life, less flexibility, and don't cure as reliably. Since CA is pricey, I have started buying a premium brand (Starbond), and found that it works out be less expensive since I'm not throwing away containers of


2. You can increase the shelf life by storing it in a cool and dry environment. 3. Always fill deeper voids in layers, or use wood dust or colored fillers mixed into the CA. (Colored additives open many possibilities for accentuating

4. When you choose thick or gel because surfaces are uneven, but you still want a quick bond – just spray one surface with accelerant before you put

5. You can control the look of CA when it will be in plain sight on an item. Progressively finer grits can take it from satin to high sheen. Also, guality CA suppliers are now making brown and black CA to blend with wood or
